
**WHAT DOES THIS FUND INVEST IN?**

The objective of the Matco Global Equity Fund is to achieve above-average long-term, risk-adjusted returns by investing in global equity securities. Capital will be allocated to the best global opportunities, which may include both large and small capitalization companies. The amount invested in any one country will vary depending upon the economic, investment and market opportunities in each area. The Fund will be primarily invested in equity and equity-related securities. The charts below give you a snapshot of the Fund's investments on April 30, 2022. The Fund's investments will change.



**AVERAGE RETURN**

As of April 30, 2022, a person who invested \$1,000 in the Series F units at the inception of the Fund now has \$1,397. This works out to an annual compound rate of 7.5% since inception September 20, 2017.

**A WORD ABOUT TAX**

In general, you'll have to pay income tax on any money you make on a fund. How much you pay depends on the tax laws where you live and whether or not you hold the fund in a registered plan such as a Registered Retirement Savings Plan or a Tax-Free Savings Account.

Keep in mind, that if you hold your fund in a non-registered account, fund distributions are included in your taxable income, whether you get them in cash or have them reinvested.

**SALES CHARGES**

There are no sales charges applicable to Series F units of the Fund. You may be required to pay a separate fee to your representative. The amount of any such fee is determined between yourself and your representative.

**FUND EXPENSES**

You don't pay these expenses directly. They affect you because they reduce the Fund's returns.

As of December 31, 2021, the Fund's expenses were 1.36% of its value. This equals \$13.60 for every \$1,000 invested.

<b>Fee-based Accounts</b>	Series F units are available to investors who are participants in dealer-sponsored fee-for-service or wrap account programs and whose broker or dealer has entered into an agreement with Matco Financial Inc. Series F units are also available for direct purchase. You may pay a fee to your representative to participate in such a program.
<b>Referral Fees</b>	Your representative may receive a referral fee in relation to your purchase and/or holding of Series F units. A referral fee that is paid on continued holdings of Series F is an ongoing fee. The amount of such fee is payable directly by Matco Financial Inc. and is dependent upon individual referral agreements that may be in place between Matco Financial Inc., the representative/referrer, and/or yourself.

**WHAT IF I CHANGE MY MIND?**




