#### MANAGEMENT DISCUSSION OF FUND PERFORMANCE

This interim management report of fund performance presents management's view of the significant factors and developments during the year that have affected the fund's performance and outlook. In this report, "Matco" refers to Matco Financial Inc., the Manager of the Fund.

## **Investment Objective and Strategies**

The objective of the Matco Canadian Equity Income Fund (the "Fund") is to achieve superior risk-adjusted returns through long-term capital appreciation by investing primarily in securities of mid to large market capitalization Canadian companies with strong fundamentals. This Fund utilizes Matco's investment management expertise with an overlay of non-proprietary management in pursuit of a Growth at a Reasonable Price (GARP) style. Matco seeks to maintain a portfolio that is well diversified between sectors, style and market capitalization. The Fund will generally be 100% exposed to stocks.

### Risk

The overall and specific risks of investing in the Fund are as described in the Fund's Simplified Prospectus dated June 5, 2023. There were no material changes to the Fund during the period that affected the overall level of risk associated with an investment in the Fund. The risk rating of the Fund is medium.

## **Results of Operations**

The Fund's net assets increased to \$91 million at June 30, 2023 from \$84 million at December 31, 2022. Total investment gain for the Period ended June 30, 2023 was \$4.8 million, prior to other income

and operating expenses, up from a \$6.5 million investment loss for the period ended June 30, 2022.

Year to date the Fund is up 5% (Series F) vs. the benchmark at 4.7%. The slight out-performance is the result of having better company selection within the Financial sector. The Fund trimmed its positions in Quebecor Inc., CI Financial Corp. and ATS Corp. The Fund added to its existing positions in CIBC, Enbridge inc., Nutrien Ltd., TC Energy Corp., Telus Corp. The Fund purchased a new position in natural producer Tourmaline Oil Corp.

#### **Recent Developments**

The Fund remains well diversified across sectors and remains under weight Energy and Materials companies relative to the benchmark. The largest sector weights are Financials 29%, Industrials 22% and Energy 15%. The Fund continues to have a bias towards more income focused sectors and as result has a dividend yield of 3.7%, which is higher than the benchmark yield of 3.2%. In addition, the Fund continues to have a significant valuation discount to the benchmark.

## **Related Party Transactions**

### Management Fees

Matco provides the Fund with investment management services, including managing the investment portfolio, providing investment analysis and recommendations, making investment decisions, making brokerage arrangements for the purchase and sale of the investment portfolio and providing other services. In return, Matco receives a management fee based on the net assets of the Fund, calculated on a daily basis.

For the Period ended June 30, 2023, the Fund incurred management fees payable to Matco of \$29,211 (period ended June 30, 2022 - \$20,178).

### Investment Review Committee

An Investment Review Committee ("IRC") has been established by the Manager in accordance with the *National* Instrument 81-107 *Independent Review Committee for Investment Funds* ("NI 81-107"). The IRC must review and approve conflict of interest matters as referred by the Manager. The Fund did not refer any related party transactions or conflict of interest matters to the IRC during the Period ended June 30, 2023 or 2022.

### **Management Fees**

The annual management fee rates, exclusive of sales taxes, are 1.75%, 1.00% and 0.50% for Series A, F and N respectively. No management fees are charged directly to Series O.

During the Period ended June 30, 2023, management fees totaled \$29,211 (period ended June 30, 2022 - \$20,218). Included in liabilities at June 30, 2023 is \$5,448 (December 31, 2022 - \$4,029) in respect of these fees.

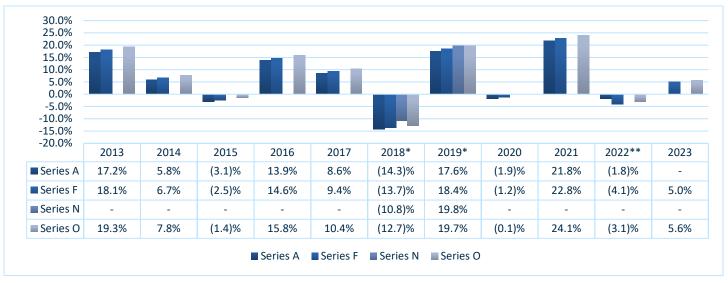
All management fees paid by Series F and N were applied to cover portfolio management and other services provided to the Fund by the Manager. No such fees were used to pay for external portfolio advisory fees, trailing or other sales commissions. Of management fees paid on Series A, 57.14% were used to pay for trailing and other dealer sales commissions, the remaining 42.86% covered portfolio management and other services provided to the Fund by the Manager.

#### **PAST PERFORMANCE**
